DISPOSITION OF ESTATE

I give, devise, and bequeath all of my property and estate, both real and personal, of every kind and description and wherever situated, to my living children to be divided among them in equal shares. If none of my children survive me, my estate shall be distributed in accordance with the laws of intestacy of the State of Texas.
