## MASTER LEASE SUBORDINATION

Subtenant acknowledges receipt of a copy of the Master Lease and agrees to abide by all terms, rules, and restrictions set forth therein. Any violation of the Master Lease by Subtenant shall constitute a material breach of this Sublease.

## SUBLEASE TERM

## RENT & UTILITIES

Any rent payments made after the due date may be subject to late charges in accordance with the laws of the State of Kansas.

All utility charges (including water, electricity, gas, trash collection, and internet) are included in the monthly rent and shall be paid by Sublandlord.

## SECURITY DEPOSIT

Subtenant shall deposit the sum of \_\_\_\_\_ with Sublandlord as security for any property damage or unpaid rent. This deposit shall be held and returned in accordance with landlord-tenant laws of the State of Kansas, which mandate deposit return and itemized damage receipts within the state statutory timeline.

### **LANDLORD CONSENT**

Lessor represents that written landlord consent is not required for this sublease, or has already been independently secured.

### **GOVERNING LAW**

This Sublease Agreement shall be governed by, and construed in accordance with, the laws of the State of Kansas.

Subtenant agrees to indemnify and hold harmless Sublandlord from any liabilities, costs, or damages arising out of Subtenant's use or occupancy of the premises.
